TO: BRUCE POWER SUPPLIERS

RE: BTU Reporting Requirements

I make reference to the supplier information call on June 30, 2020 and the presentation regarding Bruce Power's obligation to report to the Independent Electricity System Operator ("IESO") all building trades union labour hours ("**BTU Hours**") performed at the Bruce Power site. This reporting obligation is prescribed in the terms of the Amended and Restated Bruce Power Refurbishment Implementation Agreement, dated December 3, 2015 between Bruce Power and the IESO ("**ARBPRIA**").

Please be advised that all suppliers performing BTU Hours at the Bruce Power site shall be required to submit a monthly report in the form attached as Exhibit 1 hereto. The monthly report shall identify the number of BTU Hours performed by the supplier and its subcontractors. All submissions shall be made by the 15th business day of the month to BTUReport@brucepower.com. **For clarity, if you do not perform BTU Hours at the Bruce Power site, you shall not be required to submit a BTU Hours report.**

The purpose of this report is strictly to ensure compliance with Bruce Power's obligations pursuant to the ARBRPRIA. The BTU Hours reporting obligation shall be incorporated into applicable purchase orders going forward.
