

Hello,

Due to a number of questions, I would like to clarify the guidelines/requirements around entering Canada from another country to work at the Bruce Power site. As you are aware, anyone that enters Canada from any country must self-isolate for 14 days. We have had enquiries about waiving this 14 day self-isolation period for critical workers given that we are an essential service and running critical infrastructure for the Province of Ontario. Bruce Power has no ability to waive this 14-day self -solation period, it can only be provided by Canadian Border Services which is being very strict in their interpretation.

As such, anyone coming in from outside of Canada will need to get a formal exemption from Canadian Border Services when they enter Canada. This will need to happen every time they enter Canada, and there is no guarantee they will get this exemption. It is the expectation that anyone in this situation will work with their respective company who will likely have an internal process with HR/Legal to work their way through this process. Currently, the exemptions cannot be secured in advance, and it will always be up to the discretion of border control personnel when an individual enters the Country.

If an individual is successful in getting a formal exemption through Canadian Border Services, Bruce Power will also need to do an internal assessment before allowing access to any of our facilities or performing work with our staff within the normal 14 day self-isolation period. Please see the attached document that will need to provided so we can complete an assessment of the situation.

Individuals will not be provided access to any of the Bruce Power facilities unless they have formal exemption from Canadian Border Services and we have reviewed the circumstances of each individual based on their input in the attached document. It is highly recommended that each worker coming into Canada has a COVID-19 test in the days preceding entry to Canada so they can support their request to Canadian Border Services. We will also require a second test once in Canada.

Request for Bruce Power Access

(To be requested only if formal approval for Exemption from Self-Isolation from Canadian Border Services has been granted)

Note: you can only seek approval to enter a Bruce Power facility if you have been provided formal exemption from self-isolation from Canadian Border Services. If provided formal exemption, you must have a COVID-19 test at a local assessment center and provide evidence of a negative COVID-19 test. Do not go to a local COVID-19 assessment center unless you have been provided a formal exemption from self-isolation. If you have symptoms of COVID-19, contact Telehealth (1-866-797-0000) or the local Canadian assessment center.
